Participants must:

- Be a junior in high school at the time of her selection and have at least 1 semester remaining in high school
- Be between the ages of 16 and 18 years old
- Be ranked in the top 1/3 of her class academically OR have at least a GPA of 3.0
- Be residents of North Carolina for a minimum of 1 year prior to her selection for the program and be attending high school in North Carolina
- Be a US Citizen or legal resident of the United States
- Be a mature individual capable of setting priorities and be in good physical condition to withstand the week's intense activities and demanding schedule.

Rules, Regulations, and Expectations:

We understand and accept all rules, regulations, and expectations outlined on page 3 of the Participant and Parent Information Packet.

Including:

- Attend the entire 2024 session, from June 9-15.
- Attend an orientation session to be held virtually in Late April and May, 2024.
- Complete the Medical Form to be sent in May, 2024.
- Take a serious and conscientious interest in discharging the duties of a citizen of Tar Heel Girls State.
- Read and adhere to the Dress Code and Social Media Policies.
- Understand this is an Americanism program and that it is a study of City and State Government.
- If elected or appointed to office, serve to the best of your ability.
- Abide by the judgment of those responsible for this Americanism program and respect the rights of my fellow citizens and staff.

Social Media Policy

The American Legion Auxiliary (ALA) Tar Heel Girls State (THGS) program recognizes and supports its ALA THGS participants' rights to freedom of speech, expression, and association, including the use of online social networks.

- Everything you post is public information — any text or photo posted online is completely out of your control the moment it is posted, even if you limit access to your social media profiles. Information (including pictures, videos, comments, and other posters) may be accessible even after you remove it.
